3. Explanation

We hereby declare, on our sole responsibility, that the packaging described above complies with the relevant requirements set out in Regulation (EU) 2025/40 on packaging and packaging waste (PPWR), as amended.

4. Requirements met

The following requirements are met based on information available from suppliers:

- ✓ **Compliance with substances in Packaging (art.5)**
 - **Heavy Metals:** Total concentration of heavy metals (Pb, Cd, Hg, Cr VI) does not exceed 100 ppm (0.01% by weight).
 - **PFAS in food-contact packaging.** For packaging intended to come into contact with food, concentration limits for per- and polyfluoroalkyl substances (PFAS) do not exceed: 25 ppb for any individual non-polymeric PFAS; 250 ppb for the sum of non-polymeric PFAS; 50 ppm for total PFAS, including polymeric PFAS. **Not applicable:** the packaging is not intended to come into contact with food.
- ✓ **Compliance with recyclable Packaging (art.6):** subject to the applicable delegated acts and their date of application. *Recyclability performance will be carried out as soon as the delegated acts have been issued that must establish the design criteria for recycling and how to determine the affiliation to performance classes A, B and C.*
- ✓ **Compliance with minimum Recycled Content for plastic packaging (art.7):** *Minimum recycled content requirements for plastic packaging are assessed where applicable, taking into account the material, packaging use, relevant exemptions and the applicable date of application under Article 7.*
- ✓ **Compliance with Packaging Minimisation (art.10):** *as soon as applicable.*
- ✓ **Compliance with reusable Packaging requirements** if applicable (art.11).
- ✓ **Compliance with Labelling and Information Requirements (art.12)**
- ✓ **Further compliance with:**
 - **REACH Regulation (EC) No 1907/2006** - no Substances of Very High Concern (SVHC) above 0.1% w/w.
 - Regulation (EU) 2019/1021 (**POPs**)
 - Regulation (EU) 2024/3190 (**bisphenols**)

However, a significant part of the obligations set out in this Regulation still depends on the European Commission's gradual adoption of delegated acts, implementing acts and harmonised standards. These are intended to specify the technical and operational arrangements for the application of the Regulation, in particular

- ✓ delegated acts laying down the sustainability criteria for plastic recycling technologies
- ✓ Implementing acts introducing a harmonised labelling system and setting out specifications for labelling requirements and formats
- ✓ Implementing acts laying down the method for calculating and verifying the proportion of recycled material
- ✓ harmonised standards setting out the method for calculating and verifying compliance with the requirements for minimising packaging,
- ✓ delegated acts setting a minimum number of cycles for reusable packaging,
- ✓ other points, yet to be defined

These implementing measures will be adopted by the European Commission in stages between 12 August 2026 and 12 February 2030, in accordance with the timetable set out in the Regulation
